SENIOR COMMITTEE: Our next senior event will be held April 12th. It is a drive thru event where you stay in your car, drive to the door and pick up a box lunch plus other goodies. You must be registered to do so.

Registration ends April 5th. Letters with all information were sent to all seniors who participated previously. Call 708-534-6020 if you have never been to a senior event to get on our mailing list for the next event scheduled June 13, 2024, which will be

an indoor event with lunch, entertainment and bingo. Seniors must be 65 and over and live in Monee Township. We are restricted to about 100 people for indoor events, so please call early. YOUTH COMMITTEE: The Township

Youth Program was held at Coretta Scott King School in the Fall of 2023 and in Febru-ary and March 2024. We offered an hour of STEM classes in Math, Science and Robotics and an hour of recreation. Those that came enjoyed the evening but we had lower participation than expected. The Township will re-evaluate the program and try to find a better way to help our Youth in the future.

EASTER BASKET PROGRAM: The Township gave out 33 beautiful Easter Baskets in March containing toys, books and candy to children in 12 families. The baskets were put together by our office staff, Willa, Shirley and Ruth. They looked professionally made

ARPA GRANT: In 2022 we received a grant to help our Township with the continu-ing aftermath of Covid-19 problems. The Township was able to help many with much larger dollar amounts to pay our Emergency Assistance clients who needed help with rent, mortgages or utilities. The Grant money is depleted so the Township is back to the aid structure based on number of people in a household and based on Poverty guidelines. The Grant also allowed us to give out \$100 dollar gift cards with our Thanksgiving and Santa Sack programs in 2022 and 2023, along with the normal food baskets and gifts. So many people qualified and were helped with this extra gift card amount. With the grant depleted, the Township will now go back to pre-grant amounts.

UNIVERSITY PARK TIF-5: FYI: For 23 years, all taxing bodies in the TIF-5 district lost tax revenues which went into the TIF which was used for infrastructure and development of the TIF area. University Park is planning on dissolving TIF-5 this year so it will go back onto the Tax rolls. This will add approximately 93 million EAV and can only be recaptured by taxing bodies in the year it is dissolved which means it will affect our November Levy. All taxing bodies will have to hold a Truth in Taxation Hearing as to put the TIF-5 EAV back onto the tax rolls, it will be over the 5% allowable Truth in Taxation amount. My preliminary figures show it will be a 29% or 30% increase. But don't get upset, this will not be charged to local taxpay ers, it will only show up on the taxes of the companies within the TIF-5 district. If the taxing bodies do not raise the levy this year to include the TIF EAV, it will be forever lost. The Village of University Park and the School District will benefit the most as they get the

biggest portion of taxes so they will reap big rewards. The smaller taxing bodies like the Township will be helped also. It will help our Township with a renovation project for our Food Pantry. Putting the TIF-5 EAV back on the tax rolls will be a win for all and will not

affect your residential taxes. BUILDING RENOVATION: The Township is working with an architect to develop a plan to renovate the Township Building to allow room for a new pantry and better offices. We are land locked so we will be using a part of the Highway Commissioners space and building the Highway Department new bays and offices. This will allow us to have a walk-in pantry with commercial refrigerators and freezers. It will allow us to have meats and frozen foods plus room for produce and bakery items. As our Pantry use is growing monthly, we will be able to provide a better variety of foods. Right now we can only give out non-perishable foods as we do not have freezer or refrigerator capacity. It will be a great addition to our services.

Congratulations to our Monee Township Trustee and Youth Chair Billy Morgan on his primary election win which will allow him to run in November for State Representative in the 79th District against the present incumbent.

Finally, as we begin Spring and transition into Summer, I wish you good health and safe travels.

MONEE TOWNSHIP HIGHWAY COMMISSIONER'S REPORT

Our winter this year was mild with below average snowfall and above average temperatures. The snow plowing equipment has been removed from the trucks and stored for the summer months. We will be preparing for the spring and summer road work which will include mowing roadsides, fixing culverts and road repairs.

In April 2023 the highway department was informed of the need to immediately close the bridge on Highland Avenue. The concrete support beams were cracking and scaling which made the bridge dangerous to drive over. Iroquois Paving is doing the construction on the bridge along with Willett Hoffman Engineering. They have been working on the bridge this

past month and are currently on schedule. The completed bridge will need the approval of Will County and I.D.O.T. The average replacement time is usually 3 years but because replacement of the bridge was an emergency situation, the bridge is scheduled to open on May 17, 2024. We are sorry for the inconvenience the closing of the bridge has caused some residents but we had no choice but to replace it. With spring planting time almost here, please

be respectful of the farming equipment when you encounter it on the roadways. The highway department wishes everyone a safe and enjoyable summer.


General Assistance is available to persons in Monee Township, under the following guidelines: Those who are ineligible for cat-

- egorical assistance from the Illinois Department of Human Services (Temporary Assistance to Needy
- Èamilies, ŤANF) Those who are ineligible for Supple-

stances and

- Who meet the other financial and non-financial eligibility criteria
 - Who have lived at their address for six (6) months or longer.

You may receive EA up to a maximum established by the Township only once in a 12-month period. EA is paid directly to a provider (such as a landlord or utility company) to alleviate the life-threatening situation.



DIAL-A-RIDE

Monee Township has entered into an agreement with Will County Will Ride, through PACE Bus Company, for Transportation services. This will service senior residents 60 years of age or over for medical visits and disabled residents for medical visits, vocational/educational training and shopping one day a week for seniors and disabled. Once you are registered, contact Pace Dial A Ride, 1-800-244-4410, for reservations. There is a \$2 fee per ride within the Township and \$4 per ride outside the Township, which will be collected at the time of service by the PACE Bus. All riders must NOW register and have a Dial-A-Ride ID. Contact the Monee Township for more information on registration, 708-534-6020. No transportation service on major holidays: New Year's Day, Martin Luther King, Jr. Day, Lincoln's Birthday, President's Day, Good Friday, Memorial Day, Juneteenth, Fourth of July, Labor Day, Columbus Day, Veteran's Day, Thanksgiving, the day after Thanksgiving and Christmas Day.

GA provides monthly financial assistance to meet basic maintenance needs such as food, shelter and utilities, and also provides basic medical assistance.

A written application for GA must be filed with the Township. The Township will deter-mine whether you are eligible for GA within 30 calendar days of the date you file your application.

Persons who receive GA must participate in the Township's Work Training and Job Search Program.

EMERGENCY ASSISTANCE

Emergency Assistance is available to persons

- Who are eligible for GA
- Who are not receiving categorical assistance or SSI
- Who face a life-threatening situation due to loss of income, medical emergency or other unusual circum-

A written application for EA must be filed with the Township. The Township will determine whether you are eligible for GA within 30 calendar days of the date you file vour application. However, every effort will be made by the Township to make a decision within ten business days of receiving all needed paperwork. For more information, please contact the Township at 708-534-6020.

FOOD PANTRY

The Township operates a Food Pantry to provide food on a temporary basis to persons in immediate need. Foodstuffs will not be provided to supplement food stamps or on a long-term basis. Applicants are asked to apply for food stamps before receiving foodstuffs a second time. Donations are accepted year-round for the Food Pantry.

OTHER PROGRAMS

The other programs the Township provides are Thanksgiving, Christmas, Easter Basket and School Supply programs. The Township accepts donations for all programs. For more information about these programs, contact the Township Office.

LOW INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP)

The Low Income Home Energy Assistance Program helps income-eligible households pay home energy bills whose income is at or below 150 percent of the poverty level. This help may be in the form of a one-time direct payment to your utility company providing heat and/or electric or a one-time direct payment to you when your heat is included in the rent, but only if rent exceeds 30 percent of your 30-days total gross income.

Applications started October 1, 2023, for Seniors 60 years of age or over and those who are disabled, November 1, 2023 households that are disconnected from their utilities or have a disconnection notice or have less than 25% in their propane tank. December 1, 2023, all other eligible households. Documents needed to apply are: photo ID, proof of Social Security Cards for all household members, proof of gross income from all household members

for past 30 days, a copy of your current gas and/or electric bills, and if you do not pay any utility bills, all printouts from other agencies (food stamps, medical card, social security, child support), a rent receipt or lease is needed, along with landlord telephone number. Any member ages 18 or older will need proof they are or are not receiving benefits from DHS (Public Aid) and IDES (Unemployment).

Applications will also be taken in The Village of University Park at 90 Town Center Drive every Tuesday from 9:00 a.m. to 2:00 p.m. They will also be taking applications for furnace assistance. For more information, call 815-722-0722.

Assistance is available to both homeowners and renters, and can be applied to single-family residents, multiunit buildings, mobile homes, and townhouses and condos (within association guidelines).

An assessor will conduct an energy audit on approved residences to determine what measures will make the home more comfortable and energy-efficient. Once the assessment is complete, a contractor will be assigned to apply the appropriate measures. One of our staff will then assess the work to make sure each measure called for has been completed. We work with all types of homes!

The program evaluates:

Heating system: furnace will be tested and repaired

or replaced if necessary

- Insulation of exterior walls and attic areas
- Weather-stripping of doors, or replacement if needed
- Caulking of windows; repair or replace if needed
- Sealing of other bypasses that allow heated or cooled air to escape from the home
- Other energy conservation measures as funding allows, such as replacement of old refrigerators with new energy efficient models

Material and labor are free of charge to qualified homeowners. In order to provide services to leased homes or apartments, the landlord must agree to authorize work on the property and are responsible for 50% of mechanical costs when applicable.

Currently, you may make appointments for office vis-its that require some research in preparation for your visit, but for most situations, you will be able to walk in and get assistance without having an appointment. Email is still the preferred method of contact, as this is the best way to reach the Assessor directly. In addition to email, we will continue responding to voicemails, and set appointments to assist vou. as needed.

If an appointment becomes necessary, then you will be notified of a future meeting by phone or in person.

These meetings will generally be scheduled for 20 min-utes during our regular office hours. Please call or email to schedule an available time for an office visit meeting. Wearing face masks is not required but is optional for anyone who has safety concerns or if they have cold symptoms. We still have stations established with sneeze guards in 3 locations for the assistance inside our office. There will be a limit of 3-5 people inside the office simultaneously except for workshops or exemption events.

Workshops and Exemption Events Q: Did you know that exemptions saves \$\$ on tax

bills?

A: The Monee Township Assessor's Office assists with the completion of a variety of exemptions that are offered to decrease your tax bill! Exemptions are described here:

Increases in Exemptions

Based on a recent announcement at the last Board of Review meeting in July 2023, there will be the following increases in exemption amounts. General Homestead Exemption increases from

- 6,000 to 8,000
- Senior Homestead Exemption increases from 5,000 to 8,000
- (These increases will show on your tax bill received in 2024)

Disabled Veterans Homestead Exemption

This exemption allows a veteran with a service-connected disability (SCD) of at least 30% that was issued by the U.S. Department of Veterans Affairs to receive an exemption that reduces their assessment. Exemption amounts below:

- If the veteran has experienced a SCD ranging from 30%-49% will receive an exemption of 2,500
- If the veteran has experienced a SCD that ranges from 50%-69% will receive an exemption of 5,000.
- If the veteran has experienced a SCD of 70% or greater, a 100% exemption from taxes is granted.

The General Homestead Exemption is determined at the time of sale, based on the indication on the Sales document (PTAX) as the buyer's primary residence. No other action to be taken.

Additional Exemptions that decrease taxes include:

- Senior Exemption (must be 65 years or older)

- Low Income Senior Citizen Assessment Freeze

(based on a household income of \$65k or less)

- Disabled Persons' Exemption (SSI or Doctor's statement)

- Home Improvement Exemption (additions or upgrades)

Check your tax bill for exemptions to see if you have all that is due to you. If you are not sure which exemption you should have on your property or what your current exemptions are, then call us during office hours and someone will be able to assist you in obtaining this information. Do you know anyone 65 years or older? Have them contact us ASAP to verify that they have their senior exemptions.

To understand your tax bill and exemptions come to any workshop and/or Senior event scheduled in May.

Q: How does assessments relate to taxes?

A: The Assessor's office is responsible for applying fair assessment for the entire township. When assessments go down, the rates usually go up and when assessments go up, then the rate tends to go down, this allows the taxing bodies to receive at least what they received the previous year in their levy to meet their budget and up to 5% increase. Q: What are the activities that affect your tax bill?

A: 1. Each year your assessment will be adjusted by the Will County Supervisor of Assessment (SOA's) factor. Assessment increases do affect your tax bill. Often when assessments go up, then the rate tends to go down, and as a result, people with the Senior freeze exemptions may actually see savings.

2. Then your taxing bodies, like school boards, villages, township, county and others will request a levy amount to fulfill their budget needs for the year, and that also affects your bill. The levies are generally limited to the consumer price index (CPI) amount, used by the county clerk. This year that amount is 5% vs a lower amounts in past years.

3. When appeal decisions are made by the Board of Review to lower the assessment for an appellant, this affects all taxpayers that did not receive a reduction since the assessment base is lowered because of granting reductions.

4. Finally, applying exemptions to your bill will result in savings in your taxes.

BENEFITS ACCESS LICENSE PLATE DISCOUNTAND/OR RIDE FREE TRANSIT CARD
